Please note: If you receive federal aid for students in Austria (Studienbeihilfe) and are planning to go on Erasmus+, you must apply for additional financial aid for your stay abroad (Auslandsbeihilfe) at the Austrian Study Grant Authority (Stipendienstelle). You will ONLY be entitled to receive the Top-Up payment after handing in the confirmation of financial aid for your stay abroad at the OeAD. The amount of the Top-Up will be based on the regular Erasmus+ grant (depending on host country) minus the financial aid for your stay abroad payed out by the Austrian Study Grant Authority.

STUDENTS WITH CHILDREN and STUDENTS WITH SPECIAL NEEDS

Students with children and students with special needs can **apply for special financial aid** ("Sonderzuschuss") in addition to the Erasmus+ grant to cover additional costs that might occur due to their stay abroad. You will find the application form on our website (in the section "Financial matters"). Please submit the form at the International Office, where it will be signed, stamped and forwarded to the OeAD.
